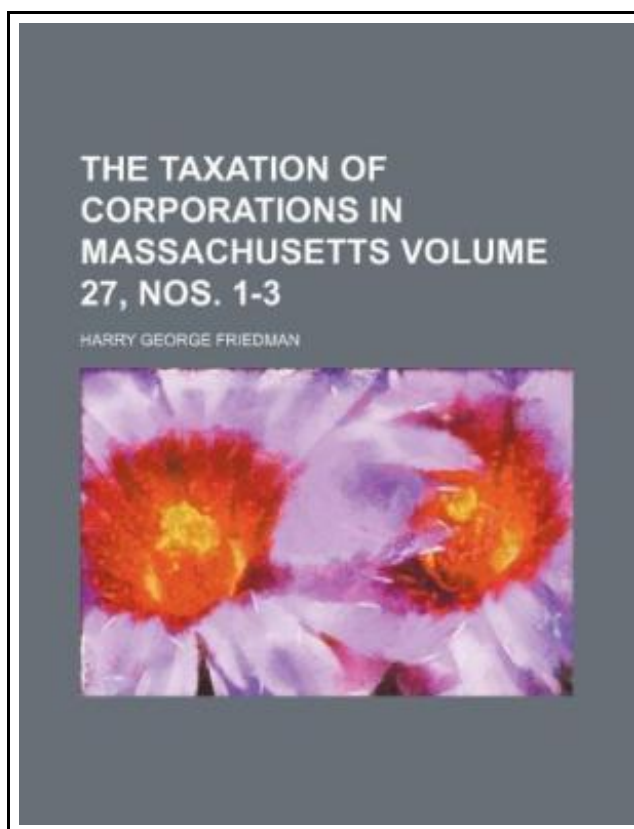

CHAPTER V Taxation Of Public-service Corporations In the taxation of public-service corporations, there are evidences in the Massachusetts law of three stages, exemption from taxation for the purpose of encouragement, taxation as ordinary corporate enterprises, and finally, special taxation for a special franchise. The early practice of exempting the property of corporations to which the right of eminent domain had been granted, such as turnpikes, canals, aqueducts, evidently had for its aim the encouragement of public works. It is true that the shares of such corporations were early made taxable, but it appears that originally the property of other corporations was taxed to the corporations, and in addition, the shares were taxed again to their owners.1 Public-service corporations were thus taxed more leniently. Taxation was in fact more favorable to public-service than to other corporations also under the general corporation tax. In the case of the other corporations, which until recently were chiefly manufacturing companies, the local taxation of real estate and machinery reached...
